Definition of European Union: EU traces its origins to the European Economic Community (EEC) formed in 1957 by the Treaty of Rome among France. West Germany, Italy and Benelux (Belgium, the Netherlands and Luxembourg). In 1973 the European Communities enlarged to include Denmark, the Republic of Ireland and the United Kingdom. In the 1981, Greece and in 1986, Spain and Portugal joined European Union and it was a community of 12 members states. Austria. Sweden and Finland joined in 1995. In 2004, ten new countries joined the EU. At the start of 2007 Romania and Bulgaria also joined the EU. The main values of EU are establishment of permanent peace, unity, equality, freedom, security and solidarity. The aims of EU are to protect the principles of freedom and democracy, and to promote respect for human rights, and ensure rule of law.

Promotion of Civil Society Dialogue (CSD) between EU and Turkey: CSD between EU and Turkey provides for implementation of four Grant Schemes and aiming at intensifying and diversifying the contacts between:Towns and Municipalities, Professional Organizations, Universities and Youth Initiatives for Dialogue.
